

**AGREEMENT FOR COOPERATION
BETWEEN THE POLYTECHNIC INSTITUTE OF BRAGANÇA
AND THE XI'AN FOX LANGUAGE & CULTURE EXCHANGE CO., LTD.**

The **POLYTECHNIC INSTITUTE OF BRAGANÇA**, hereinafter referred to as **IPB**, a public higher education institution, located in Campus de Santa Apolónia, Bragança, Portugal, website www.ipb.pt, and represented by the President, **Prof. Dr. João Alberto Sobrinho Teixeira**, and the Xi'an Fox Language & Culture Exchange Co., Ltd. (in Chinese called 西安富克斯语言文化传播有限公司), hereinafter referred to as **FOX**, register number 610131100030368, located in B610, Pioneering Mansion, First Hi-tech Rd., Hi-tech Zone, Xi'an City, Shaanxi Province, China, website www.xuepuyu.com/en, and represented by the Manager, **Dr. Hu Wenzheng** (in Chinese named 胡文政), celebrate this **Agreement for Cooperation**.

CLAUSE 1 – General object of the agreement

IPB and FOX agree to promote cooperation between the two institutions and, according to predefined priorities, to cooperate on the development of teaching activity in common interest areas and to promote and facilitate the international exchange of students and teachers.

CLAUSE 2 – Teaching Cooperation

IPB and FOX agree to cooperate in teaching Portuguese Language and Culture, according to the Common European Framework of Reference for Languages. This cooperation can be achieved by teacher's international mobility and by the design of specific courses for the FOX students at the IPB.

Detailed proposal of the objectives and the financial costs shall be further negotiated by both parties at a later date.

CLAUSE 3 – Student Exchange

IPB and FOX agree to cooperate in student's exchange, particularly, in the enrolment of students from the People's Republic of China in the IPB's academic programmes, including Technological Specialization Courses, Undergraduate (Bachelor) and Graduate (Master) programmes.

Detailed proposal of the objectives and the financial costs shall be further negotiated by both parties at a later date.

CLAUSE 4 – FINAL DISPOSITIONS

The proposal of common projects and the communication between IPB and FOX will be ensured by representatives of each Institution, being Prof. Dr. Luís Manuel Santos Pais, ID 7731366 and Portuguese Passport number H548415, Vice-President of IPB and Dr. Luís Filipe Martins Pinto, ID 11250193 and Portuguese Passport number J365072, Director of the Education Department at FOX.

The present agreement will come into effect on the day of its signing, and shall continue in force for a period of two years.

The present agreement can be terminated by any of the parts involved, if formally communicated, subject to giving ninety days prior written notice, or in case of legal impediment. In any case, the continuation of the projects in course shall be guaranteed.
